Machine Shop Social Enterprise - Nineteen formerly gang-involved individuals released from incarceration were employed in the machine shop in 2022. All graduates were hired immediately upon graduation in well-paying jobs with local manufacturing companies.

Member Services - Case Management and Counseling Services were provided to all of RUI's trainees. Each new trainee participated in an initial counseling assessment and subsequently received individual and group counseling sessions if they chose to do so throughout the 18 month reentry program. Case Management is offered to each trainee to assist with obtaining services from other agencies and organizations, such as health care, drivers licenses, housing, and other personal needs. Rise Up Industries' counseling services comprised a mixture of volunteer and paid contract counseling.

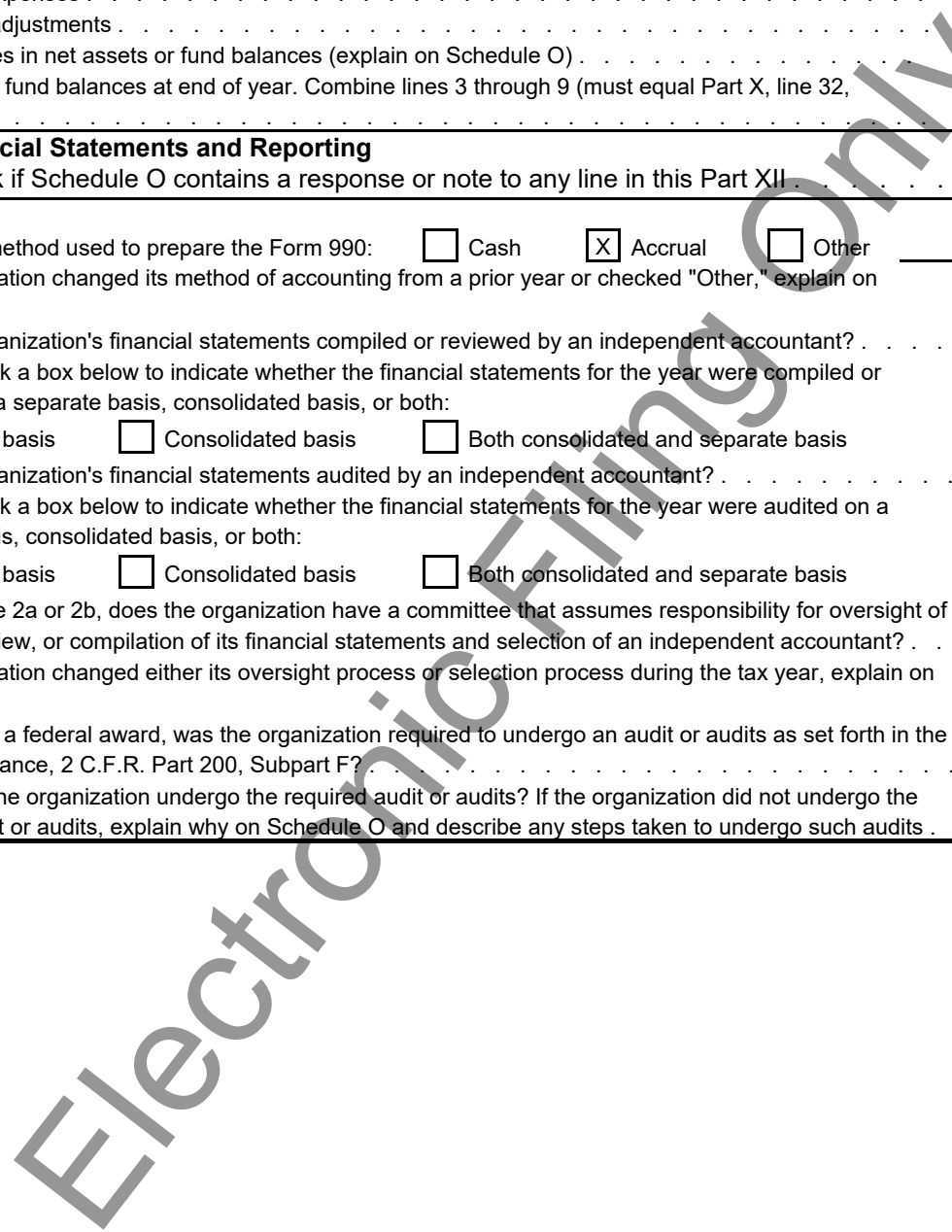
